# 2021-2022 HSBC Business Debit Mastercard® Acquisition Reward Offer (this "Promotion")

#### Terms and Conditions

# Eligibility

- 1. The promotional period is from 1 December 2021 to 31 December 2022, both dates inclusive (the "Promotional Period").
- 2. This Promotion applies to HSBC Business Debit Mastercard(s) ("Eligible Card(s)") issued to a company or business enterprise (a "Company") by The Hongkong and Shanghai Banking Corporation Limited, Hong Kong (the "Bank") within the Promotional Period.
- 3. In addition to these Terms and Conditions, the Terms and Conditions applicable to HSBC Business Debit Mastercard as set out in the Business Integrated Account General Conditions will continue to apply.
- 4. A Company is not entitled to participate in this Promotion (as set out in clause 5 below) if:
  - (a) an Eligible Card is terminated by the Company or the Bank before the expiry of six months from the commencement date of the Eligible Card\*; or
  - (b) on the date the cash rebate is to be credited to the Company's Business Integrated Account, (i) the account is closed or (ii) restrictions or conditions have been imposed on the account.

## Reward Offer

- 5. Subject to other clauses in these Terms and Conditions, a Company shall receive a cash rebate of HK\$500 if an Eligible Card accumulates spending amount of HK\$10,000 or above (HKD or equivalent) on Eligible Transaction(s) within 90 calendar days from the clearing date of the first transaction of the Eligible Card^. The clearing date of the first transaction must be within the Promotional Period.
- 6. Eligible Transaction(s) shall mean posted local and overseas transactions with original sales slips and online transactions effected under an Eligible Card that do not fall under the categories of transaction set out in Appendix 1. In addition, online bill payments, tax payments, autopay, recurring transactions, ATM withdrawals, all fees and charges, cancelled/refunded transactions and all transactions without original sales slips such as telephone orders, fax orders and mail orders are not Eligible Transactions.
- 7. The Bank has absolute discretion to determine if a transaction is an Eligible Transaction and the eligibility of a Company to receive the cash rebate.
- 8. The cash rebate will be credited to the Company's Business Integrated Account within 4 months from the clearing date of the first transaction of the Eligible Card^.

### General

- 9. If the Bank determines, in its sole discretion, there has been any fraudulent or abusive use of an Eligible Card, the Bank may forfeit the Company entitlement to the cash rebate. The Bank reserves the right to deduct the cash rebate awarded to the Company directly from its Business Integrated Account without prior notice.
- 10. In case of disputes arising out of this Promotion, the decision of the Bank shall be final and conclusive.
- 11. The Bank reserves the right to suspend and/or terminate this Promotion, and/or vary these Terms and Conditions at any time without prior notice. The Bank accepts no liability for any such change, suspension or termination.
- 12. No person other than the Bank and the Company will have any right under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefit of any of the provisions of these Terms and Conditions.
- 13. In case of discrepancies between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.
