



Examples for Change of Physical Signing Instructions

更改實體簽署指示的例子

You can set out your physical signing instructions by following this example. Please note that physical signing instructions must be given in English.

你可以按照以下例子設定你的實體簽署指示。請注意，只接受英文實體簽署指示。

The physical signing instructions provided will supersede ALL the existing physical instructions of the selected account(s). You need to set out ALL the physical signing instructions applicable to the selected account(s). For instance, if you have 2 existing signing instructions and need to add a new one, you have to set out all three signing instructions. 此節提供的實體簽署指示將取代指定戶口先前提交的所有實體簽署指示，因此你需列出指定戶口的所有實體簽署指示。例如，你現有2項實體簽署指示並需新增一項實體簽署指示，你需列出所有3項簽署指示。
