How to Make Payments to Your Account:

- Please instruct your bankers to send their payment instruction to us (HSBCHKHKKH) by SWIFT MT103 with **the following details.*
- If your bankers cannot send their payment instruction to us direct, please instruct them to make arrangement with any of our #Group Offices/Correspondent Banks to send their payment instruction to us (HSBCHKHKKH) by SWIFT MT103 with **the following details.*

* **The following details are required on MT103 to HSBCHKHKKH:**

<u>Field Name</u>	<u>Tag Field in SWIFT Format</u>
- Payment CCY and Amount	Tag 32A
- Reimbursement instruction	Tag 53/54
- Beneficiary Bank's name	Tag 57A (Remark: It is not required if beneficiary bank is same as receiving bank)
- Beneficiary's account number	Tag 59 (Reference 1 for an Integrated account)
- Beneficiary's name	Tag 59

Reference 1: If you want us to credit the remitted fund to your HKD or the respective foreign currency savings sub-account in your integrated account, please provide your account number with suffix 833, 838 or 888. You may check the account details through our Personal Internet Banking or contact our customer service hotlines. On the other hand, if a HKD current account ending with suffix 001 is specified, the remitted fund will be converted to HKD and credited to your current account at the prevailing exchange rate.

Beneficiary account number for crediting an Integrated account in HSBC HK as below:

- HKD or Foreign currency savings account, ie account with suffix 833, 838 or 888 (For your account details, please contact any HSBC branch, customer service hotlines or through Personal Internet Banking)
- HKD current account, ie account with suffix 001, may involve exchange with the payment is not in HKD

Examples: USD payment to USD savings account, beneficiary account example = 000123456838 (without exchange)

CNY payment to CNY savings account, beneficiary account example = 000123456888 (without exchange and CNY Savings account is already opened)

USD payment to HKD savings account, beneficiary account example = 000123456833HKD (with exchange)

GBP payment to HKD current account, beneficiary account example = 000123456001 (with exchange)
