Remote account opening for business is eligible for:

- A limited company / partnership / sole proprietorship
- Incorporated / registered in Hong Kong
- Operating in Hong Kong or in mainland China
- Not having any corporate directors / shareholders
- Having up to 2 connected individuals

Directors / authorised signatories who hold a mainland China resident identity card or a passport issued by 14 countries and territories<sup>\*</sup> may be invited to join a video conference or face-to-face meeting for identity verification. If your company does not meet these criteria, you can still submit your application through our mobile app and book an appointment at your nearest HSBC Business Centre Act now!
