



2022 PayMe 0% Transaction Fees for New Merchants

1. The registration for 2022 PayMe 0% Transaction Fees for New Merchants promotion will start from 1 June 2022 00:00am and end on 30 Nov 2022 11:59pm (both dates inclusive) ("**Registration Period**").
2. This promotion applies to merchants who will register for their first PayMe for Business account via the PayMe for Business app or HSBC Business Internet Banking portal during the Registration Period ("**Eligible Merchant**"). Merchants need to be HSBC Commercial Banking customers and HSBC Business Internet Banking customers to sign-up for PayMe for Business.
3. Merchants who have an existing PayMe for Business account or have registered prior to the Registration Period are excluded from this promotion.
4. Each Eligible Merchant will enjoy 0% transaction fees (the "**Fee Holiday**") on their PayMe for Business account for all payments received online or via the PayMe for Business app and / or physical PayCode for a period of 6 months from the start of the 2022 (Phase II) Consumption Voucher Scheme* ("**Promotion Period**"). For this purpose, an Eligible Merchant shall ensure that they complete their PayMe for Business registration and that their account is active.
*To be updated following the government's official confirmation of Consumption Voucher Scheme Phase 2 start dates.
5. Merchants who use PayMe for Business services under acquirer services are not eligible to this promotion.
6. Payments received via the point-of-sale terminal, device or cashier machine are excluded from the Fee Holiday.
7. The Fee Holiday is not transferrable and cannot be enjoyed in conjunction with any other pre-approved preferential pricing offered by the Bank, discount, promotional offer, programme or any merchant discount rate adjustment on PayMe for Business services for 12 months following the end of the Promotion Period unless otherwise notified by the Bank.
8. In case of disputes arising out of this promotion, the Bank's decision shall be final and conclusive. Any fraud and/or abuse of any offer under this promotion will result in forfeiture of an Eligible Merchant's entitlement to the Fee Holiday.
9. The Bank reserves the right to, at the Bank's sole discretion at any time and without prior notice, replace the Fee Holiday with an alternative gift or preferential

offer, amend these terms and conditions or terminate this promotion. The Bank accepts no liability for any such changes and/or termination.

10. In the event of any discrepancy or inconsistency between the English and Chinese versions of these terms and conditions, the English version shall apply and prevail.
11. The Bank reserves the right to determine at its sole discretion the eligibility of an Eligible Merchant who can enjoy the Promotion.
12. Employees of the Bank are not eligible to participate in the promotion.
13. These terms and conditions are governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region ("**Hong Kong**"), and the Bank and each Eligible Customer agrees to submit to the non-exclusive jurisdiction of the courts of Hong Kong.
