



**Notice of Change on Business Account Rules for Deposit Accounts - Hong Kong Dollar Statement Savings Account, CombiNations Statement Savings Account, Renminbi Savings Account, Renminbi Commercial Current Account, effective 27 Jan 2025 (the "Effective Date")**

We have consolidated the following account rules that respectively apply to Hong Kong Dollar Statement Savings Account/ CombiNations Statement Savings Account/ Renminbi Savings Account/ Renminbi Commercial Current Account ("Deposit Accounts") into one document: The Business Account Rules on Deposit Accounts. With effect on and from the Effective Date, the Business Account Rules on Deposit Accounts will apply to you if you are using one or more of the Deposit Accounts list above.

Please note that the Business Account Rules on Deposit Accounts shall be binding on you if you continue to use or retain the relevant account(s), product(s) or service(s) on or after the Effective Date. If you decline to accept the Business Account Rules on Deposit Accounts, you have the right to terminate your account(s), product(s) or service(s) before the Effective Date in accordance with the relevant clauses under the existing applicable terms and conditions.
